### **The Opportunity:**

Reporting to the Assistant Manager, Technology Equipment Maintenance, as a Transit

Technologist you will provide technical operations support, maintenance, testing, troubleshooting and repair of electronic fare system equipment. You will collect, analyse and research data generated by same and prepare statistical/narrative reports. You will also collect and maintain technical data files to support software configurations and support installation of hardware and software upgrades and new equipment configurations.

Current Assignment: You will work with system vendor and Region staff to support fare system equipment including ticket vending machines, platform validators, fare boxes and handheld card readers. Work with vendor teams to ensure installations are performed according to Region requirements. Work with installation teams to ensure integration with existing Automatic Vehicle Location (AVL) components is successful. Help with acceptance testing of fare system hardware and software. Perform field fingertip maintenance of fare system equipment as necessary. Help test implement changes to system tariff.

### **Apply your Knowledge, Skills & Abilities:**

- Strong knowledge of electronic circuit theory, electronic displays and components, electronic hardware interfacing, computer systems and peripherals, diagnostics, printed circuit board construction, soldering and de-soldering, and mechanical compositions, normally acquired through the attainment of a 3-year Community College Diploma in Electronics Engineering Technology or equivalent discipline, plus 3 years of related work experience.
- Knowledge of and ability to follow policies, procedures, and related legislation and guidelines (e.g., Highway Traffic Act, health and safety, Transport Canada Acts and Regulations, Workplace Hazardous Materials Information System, Ministry of Transportation).
- Analytical and technical skills, plus a proven ability to analyze, diagnose, and resolve electronic problems and configurations.
- Human relations, communications and organizational skills to work independently; develop short and long term plans; respond to technical inquiries; respond to technical inquiries from equipment manufacturers and all levels of staff with regards to equipment; to obtain, clarify, or provide information as required; and participate as an effective team member.
- Computer skills with ability to use software such as MS Office, Acrobat Reader, a document management system, Hastus, GIS, ITS software (CAD/AVL & fleet maintenance software) and integrated fleet management computer systems.
- Ability to read technical manuals, updates, bulletins, industry publications, and magazines to monitor and evaluate current technologies for applicability to GRT.
- Ability to prepare statistical and narrative reports using data generated from the various components of the ITS system.
- Must have a valid G driver's license (or G2 with 3 years of driving experience) to operate corporate vehicles.
- Ability to support and demonstrate the Region's values.
