What will I be doing?

- Conducting transportation analysis to develop and evaluate proposals for improved fare and service integration between transit agencies.
- Utilizing Power BI tools to generate and interpret ridership data from across the Region. Develop tools and dashboards to support planning analysis.
- Monitoring and analysing transit service integration to identify and develop opportunities for improving quality, efficiency and effectiveness.
- Providing transportation planning expertise and support to the Transit Integration team.
- Analysing service integration gaps and support development of solutions and pilot projects
- Measuring the impact of fare and service integration programs and projects
- Supporting the management of transit integration projects, strategic corporate planning projects, externally mandated projects, and other corporate initiatives.
- Support ongoing engagement with local transit agencies to support improved service integration and transit mode share to stations

What skills & qualifications do I need?

- Minimum Diploma in Transportation Planning, Urban Planning, Transportation Engineering, or any combination of education, training and experience deemed equivalent
- Minimum 4 years of progressively responsible experience in the transportation planning or transit infrastructure planning field
- Knowledge of the theory, principles, and practices of transit planning and service delivery, with the ability
 to integrate transit planning with corporate objectives, market research, and other transportation and
 land use planning.
- Knowledge and expertise in bus and/or rail service scheduling would be an asset.
- Strong project management and technical analysis skills, including data management, quantitative analysis, ridership forecasting, and cost estimation.
- Experience with BI tools
- Policy development/implementation experience is an asset.
- Proficiency in the use of spreadsheet, database, presentation, and word processing computer applications
- Excellent analytical, oral, and written communication as well as interpersonal skills
